## **NOTES:**

1. Full payment must accompany all orders of certificates and services from the Marky Cattle Assoc.
2. Registration fees are based on the date of postmark, indicating the date mailed by the applicant.
3. The Association operates on a cash basis. If the correct fee does not accompany the application, certificates may be held in the office until payment is made in full.
4. A member is considered "Non-Active" if Annual Dues are not paid within 30 days of due date.
5. To register an animal, fill of the Application for Registration form **COMPLETELY**.
6. Birth Weights, Weaning Weights and Yearling Weights are required.
7. DNA typing is required for all Fullbloods. To receive a DNA kit, you must send a request to the Association. You will then receive the preliminary forms. Complete this form and send it to the Association with the appropriate fees. The official forms will be completed and sent to you for your signature along with the testing kit. Follow the instructions on the form for pulling tail hairs for the sample. The sample should be sent directly to the lab. If one or more of the parents of the animal being registered is not DNA typed, then a blood typing test must also be completed.
8. To transfer ownership of a calf that has not been registered, the seller should fill out the Transfer section of the Application for Registration Form (in addition to the rest of the required information).
9. To transfer an animal after it is already registered, fill out the application for transfer on the back of the registration certificate and mail the certificate to the Association with the appropriate fees.
10. Tattoos: (suggested practice). The right ear should have a year letter in the tattoo. The left ear should contain the breeder's herd prefix. Calves born in 2002 should have the year letter "L", 2003 - "N", 2004 - "P", 2005 - "R", 2006 - "S", 2007 - "T", 2008 - "U", 2009 – "W", 2010 – "X", etc.
